Principles

At The Anthony Roper Primary School:

- We ensure that teaching and learning opportunities meet the needs of all of the pupils.
- We ensure that appropriate provision is made for pupils who belong to vulnerable groups, this includes ensuring that the needs of socially disadvantaged pupils are adequately assessed and addressed.
- In making provision for socially disadvantaged pupils, we recognise that not all pupils who
 receive free school meals or who are adopted will be socially disadvantaged
- We also recognise that not all pupils who are socially disadvantaged are registered or qualify
 for free school meals. We reserve the right to allocate the Pupil Premium funding to support
 any pupil or groups of pupils the school has legitimately identified as being socially
 disadvantaged.
- Pupil premium funding will be allocated following a needs analysis which will identify priority classes, groups or individuals. Limited funding and resources means that not all children receiving pupil premium will be in receipt of interventions at one time.
- The majority of our targeted pupil premium funding will be aimed at accelerating progress, moving children to at least age related expectations. Initially this will be in English and Maths.
- Pupil premium resources may also be used to target able children on FSM or who are adopted, to achieve 'Working at greater depth within the Expected Standard' at the end of KS1 or KS2

Barriers to Learning

In School

A Baseline skills in literacy, particularly writing, are lower in the EYFS for PP pupils than for other pupils.

B 75% of Year 1 pupils eligible for PP are not currently predicted to reach the required standard for phonics screening

C More PP pupils unable to attend residential trips due to financial implications

External Barriers (e.g. attendance)

D Attendance rates for pupils eligible for PP (88.8%) are below the target for all children (96%)

Outcomes:

100% of teaching and support staff now trained in phonics for KS2 pupils

Read Write Inc programme is continuing with 1-1/small group support for pupils who did not meet the required standard in Year 1 phonics screening.

10 Pupil Premium pupils have access to the Lexia programme and are making good progress through the levels.

Booster classes took place in terms 3 and 4 to support year 6 pupils not achieving expected **progress** or above

- *50% Year 6 Pupil Premium pupils (1 pupil) made expected **progress** in **reading**, **writing and** maths combined
- *100% Year 6 Pupil Premium pupils (2 pupils) made expected **progress in reading** (against individual subject level)
- *50% Year 6 Pupil Premium pupils (1 pupil) made expected **progress in writing** (against individual subject level)
- *100% Year 6 Pupil Premium pupils (2 pupils) made expected **progress in maths** (against individual subject level)
- * 100% Year 6 Pupil Premium pupils (1 pupil) attained levels at or above national expectations in reading
- * 50% Year 6 Pupil Premium pupils (1 pupil) attained levels at or above national expectations in writing and GPS
- * 100% Year 6 Pupil Premium pupils (pupils) attained levels at or above national expectations

Booster classes took place in terms 3 and 4 to support year 2 pupils not on target to reach expected levels

- *75% Year 2 Pupil Premium pupils (3/4 pupils) reached the expected level in reading *75% Year 2 Pupil Premium pupils (3/4 pupils) reached the expected levels in writing *75% Year 2 Pupil Premium pupils (3/4 pupils) reached the expected levels in maths
- *75% Year 1 Pupil Premium children (3/4) met the required standard in the Statutory phonics screening
- *100% Year 2 Pupil Premium children (2/2) met the required standard in the statutory phonics screening re-take
- *100% EYFS Pupil Premium pupils (3/3 pupils) achieved a minimum of 30 points plus (out of a possible 51) and achieved a Good Level of Development
- 3 pupils were able to go on school residential visits

Class trips enrich the teaching and promote deeper understanding of the learning – they are experiences we cannot give them in the classroom. All pupils gained in confidence as a result of the residential trips. They all attempted new experiences and achieved success.

- 1 pupil was provided with funding for music lessons
- 3 pupils had a subsidy provided for school uniform and PE kit
